

Terms & Conditions

The Lauristons Refer a landlord Promotion (the "Promotion") is being promoted by Lauristons Limited having its registered office at 2nd Floor, Gateway 2 Holgate Park Drive, York, England, YO26 4GB ("the Company"). Please read the following terms and conditions carefully. These terms and conditions govern the Promotion. Entry into the Promotion is deemed acceptance of these terms and conditions.

Key Terms
